

Scope of Work Narrative - Capacity Building and Planning

1. The key resource needed by Grayson County at this time is technical assistance in developing a Resilience Plan as outlined by DCR, and certification of the County's Floodplain Manager. The Plan will help determine knowledge, skills and abilities of existing staff and identify any additional staff and/or resources needed. Grayson will collaborate with regional resources and/or seek external funding in order to meet specific needs that may not be available at the county level. The County Emergency Services Coordinator/Director, Public Service Authority will oversee any policy changes and capacity needs as outlined through the Plan. These two key elements will strengthen Grayson's prevention and response to flooding issues working in tandem with the County's integrated system of tracking and documenting disasters and the ability for FEMA to load relevant parcel zone data for quick reporting.

The 2018 County Comprehensive Plan, https://www.graysoncountyva.gov/comprehensive-plan1/, references flooding as a major concern:

- Strategy 8.2: Conduct education and outreach to floodplain property owners.
- The plan discusses flash flooding as an expected hazard of the mountainous topography and abundance of streams, and discusses that, "Flooding has been identified as the number one hazard for Grayson County and is listed as such in the 2018 update." (p. 11-8, County Comprehensive Plan).
- Floodplain development is guided by the Grayson County Floodplain Ordinance as mandated by Federal Emergency Management Agency (FEMA). (p.11-8)

- 2. The overarching goal of the proposed project is for Grayson County to respond appropriately to existing repetitive flooding issues as well as identify and prevent potential flooding issues. The objectives are 1) to engage qualified technical assistance to develop a Resilience Plan encompassing required components as stated by DCR and 2) to provide certification of the County's Floodplain Manager. With these items in place, Grayson intends to implement the Plan and further increase capacity to respond and prevent flooding, and specifically, to apply for future DCR funding for construction of an improved stormwater drainage system in the vicinity of Fries Middle School.
- 3. The requested funding would be utilized to prepare a Flooding Resilience Plan and certify the County Floodplain Manager, benefitting the County and the incorporated municipalities within. Grayson County has been working with the Town of Fries, in particular, as recurrent flooding over several years has been identified at Fries Middle School. Flash flood damage

incidents have been recorded over several years including a period of four years in which the school was closed due to mold damage, with students transferred to other County schools.

- 4. Once funding is secured, Grayson will procure professional engineering services for a private firm to prepare the Flooding Resilience Plan and register the Floodplain Manager for certification training. The contract with the consultant would stipulate the timeframe for Plan development. It is anticipated that the required timeframe for plan development would be approximately 6-8 months. Grayson County desires to have the Plan and certification completed in sufficient time to identify and request construction funds for the highest priority need during DCR's 2023 construction funding application cycle.
- 5. Grayson County will engage the expertise of The Lane Group in developing the Resilience Plan. They have worked with Grayson on related projects and are familiar with the County and the region in addition to providing specific expertise for developing the Plan. The County will rely upon guidance from the Lane Group regarding the best pathway for CFM training and certification as well. We have done preliminary research through the VA and National Floodplain Manager Associations.
- 6. The expected result of the proposed project is a Resilience Plan as outlined by DCR and may include additional components as deemed necessary and/or relevant, and certification of the Floodplain Manager. Success will be measured by the development of said Plan and the certification process. Additional benefits will be capacity building of the County moving forward, and greater potential for funding to address identified flooding issues.
- 7. The County Emergency Services Coordinator/Director, Public Service Authority in conjunction with relevant partners, collaborators and consultants, will utilize the Plan as a guide in maintaining capacity going forward.

Budget Narrative - Required for All Grant Categories

• Estimated total project cost:

The total project cost of \$75,565 is composed of:

- The estimated cost of service for a private consultant to prepare the Grayson County Flooding Resilience Plan is \$75,000.
- The estimated cost of Floodplain Manager training and certification is \$565. The County will cover any travel related costs for certification.

• Amount of funds requested from the Fund: This is the total amount of any grant assistance sought from the Fund. Include a detailed breakdown of how this funding is proposed to be allocated. Grayson County is requesting a waiver of the 10% match, thereby requesting a total of \$75,565 from DCR for this project.

As Grayson requests a waiver of the full or partial match (as deemed appropriate by DCR), we provide the following context of the County, which includes the towns of Fries (population of 444), Troutdale (163), and Independence (877). The population of Grayson County is 15,333. About 50% are ages 50 and older, with 24% being 65 and older, many of whom live alone in remote areas. The county's unemployment rate is 5.5% compared to the state average of 4%. Median family income for Grayson County is \$47,900, which is 58% of the median for Virginia, of \$81,947.

According to the 2018 Mt. Rogers Planning District Commission Comprehensive Economic Development Strategy, Grayson has the lowest median income in the service area. In a comparison with state data, Kids Count (2018) indicates 27.5% of children live in poverty in Grayson County compared to 13.8% for Virginia, and 23% of children in Grayson experience child food insecurity compared to 12.5% for Virginia.

A 2020 DHCD Report on Local Vulnerability Analysis ranks Grayson County as third from the bottom in dependence on local tax revenue. Grayson joins Bland County and Galax City in highest percentage of residents working outside of the county/city, with each above 35 percent, which also contributes to decreased spending/revenue in the county of residence.

Within a larger context, the Economic Innovation Group provides a Distressed Communities Index (DCI) which examines economic well-being at the zip code level. With a Distressed Communities Index of 96.1, Grayson County ranks as a highly distressed area. The index looks at indicators such as percent obtaining a high school diploma, the poverty rate, median household income, employment, and housing vacancy. In a comparison with state data, Kids Count (2018) indicates 27.5% of children live in poverty in Grayson County compared to 13.8% for Virginia, and 23% of children in Grayson experience child food insecurity compared to 12.5% for Virginia.

As Va. Tech Economist, Dr. Sheryl Bailey shared, the pandemic delivered "deep blows to minorities, low-wage workers, women, and workers with less than college degree." Workers do not have skills for needed jobs, and workers with lower education are experiencing more impact of COVID. 21% of Grayson residents age 25+ have less than HS graduation compared to 13% in US, and 10.7% age 25+ have a bachelor's degree or more education compared to 30.3%

in US. Small and minority owned businesses are always more vulnerable: about 40% of Grayson's small businesses are owned by women.

Additionally, the Centers for Disease Control and Prevention Social Vulnerability Index (SVI) refers to a community's capacity to prepare for and respond to the stress of hazardous events ranging from natural disasters, such as tornadoes or disease outbreaks, to human caused threats, such as toxic chemical spills. The Index examines indicators of 1) socioeconomic status, 2) household composition & disability, 3) minority status and language, and 4) housing type and transportation. Index scores range from 0 (lowest vulnerability) to 1 (highest vulnerability). The Grayson County SVI score of .64 indicates a moderate to high level of vulnerability. Further breakdown of the score indicates that Grayson lies within the second highest tier of overall vulnerability, within the highest tier for socioeconomic status, the second highest tier for household composition/disability, the lowest tier for race/ethnicity/language, and the highest tier for housing/transportation.

Within the context of the recent county budget and particularly with the infusion of American Rescue Plan Act (ARPA) funding, County administration and the Board of Supervisors ranked their top priorities as 1) water and stormwater infrastructure, 2) emergency services, and 3) childcare.

Although the County has experienced repetitive flooding, attempts at addressing the issue have fallen short with lack of required foundational items to secure funding and meeting required match. Having a Resilience Plan in place and a Certified Floodplain Manager will provide the County with a good foundation to move forward. While we are requesting a waiver, Grayson understands and is willing to provide a reasonable match as deemed appropriate by DCR.

 Amount of cash funds available: This amount, when combined with the amount of funding requested from the Fund, must reflect the total estimated project cost to demonstrate that all necessary funding has been secured to complete the project. While the County requests a full or partial waiver of the 10% match for Capacity Building and Planning Grants, Grayson County commits to paying the full 10% of the total estimated project cost, which would equate to \$7,556.
